Project Partners and/or Collaborators: City of Urbana, ODOT, & LUC

This project improves both bike path crossings along a railroad and a busy roadway intersection just north of downtown Urbana. The project focuses on bicycle and pedestrian safety improvements, improving the bike trail crossings with signage, striping, and flashing beacons.






