Zoning Text Amendment

Amend Article II Definitions by amending the definition of "Nursery, Nursing Home" as follows:

Nursing Home. A home or facility for the care and treatment of babies, children, pensioners or elderly people used for the reception and care of individuals who by reason of illness or physical or mental impairment require skilled nursing care and of individuals who require personal care services but not skilled nursing care. A nursing home is licensed to provide personal care services and skilled nursing care.

Amend the Official Schedule of District Regulations as follows:

In the conditional uses list in Column 3 of the U-1 Rural District, add "Nursing Home" to the list of conditional uses.
